Deadline for ALL applications is Thursday, October 16, 2014.

### Step 2: EXHIBITOR CRITERIA

Exhibitors may only display, promote or describe products, methods or services that meet the listed criteria on the following page, with the exception being a non-conforming product used to highlight the kinetic art qualities of the conforming product. All exhibitors' applications will be reviewed by the 2014 International Kinetic Art Exhibit and Symposium Committee. Applicants that are not accepted will be notified by email. Applications may not be accepted if:

- Spaces are full for category and/or space available.
- Application is NOT complete.
- Products or service that are not Kinetic Art related.
- Kinetic Art is not made by an artist

### Step 3: PAYMENT AUTHORIZATION

**The minimum booth fee is \$199.** An exhibitor can request a larger booth size by applying for more than one in a row and the fee will be multiplied by the number of booths requested. An invoice and link to online payment will be sent to the contact email address upon application approval. Please proceed with payment online or return the invoice with your check for full payment for confirmation of booth space. Checks are to be made payable to City of Boynton Beach (*Registrant's name and account number must appear on check.*)

### Step 4: EXHIBITOR INFORMATION, RULES, & REGULATIONS

**BOOTH SPACE:** Space is limited and will be assigned as completed application and payment is received. Preferred Applications received by October 2, 2014 will receive booth spaces. **Booth reservations may be cancelled in writing for a 50% refund prior to December 1, 2014. There will be no Exhibitor refunds after December 1, 2014.**

You will receive booth assignment and information prior to December 1, 2014.

**DISPLAY AND ADDITIONAL ITEMS:**

- Display space includes a six-foot table and two chairs. Additional items must be pre-approved and may require an additional cost.
- The exhibitor’s area must be fully staffed during event hours.
- Exhibitors may not dismantle their booth prior to the close of the event.
- Exhibitors are not permitted to solicit or distribute products outside of their booths.
- Exhibitors are strictly prohibited from selling their assigned space to another company and/or individual or share their booth with any non-applicant.
- Exhibitors may only display, promote or describe products, methods or services that meet the listed criteria, with the exception being a non-conforming product used to highlight the Kinetic Art qualities of the conforming product.
- Exhibitors may not sell edible products.

**Step 5: EXHIBITOR RELEASE**

- 1.** In consideration for the acceptance of the Exhibitor application, I have read and understand the exhibitor information above and I agree to the enforcement of all policies, rules, and regulations of the International Kinetic Art Exhibit and Symposium and City of Boynton Beach, Florida. I understand that failure to abide by stated rules and regulations allows the City of Boynton Beach, Florida the right to ask me to leave. I understand that in such circumstance, I will not be entitled to a refund of my Exhibitor Fees. The City of Boynton Beach, Florida also reserves the right to refuse any exhibitor application not meeting event criteria.
- 2.** I acknowledge that the information supplied is correct and that I agree to only display, promote and/or describe products or services that meet these criteria. I agree to sell only those products approved by 2014 International Kinetic Art Exhibit and Symposium Committee. I assume liability for the soundness and safety of any product I sell and agree to indemnify, defend and hold harmless the City of Boynton Beach for any claims arising out of such products.
- 3.** I acknowledge full responsibility for all my activities and actions at the 2015 International Kinetic Art Exhibit and Symposium and for those employed or assisting me. I further agree to defend, hold harmless and indemnify the City of Boynton Beach and the 2015 International Kinetic Art Exhibit and Symposium from any liability, cost, damage or expense which arise from my, my employee’s or my agent’s involvement and operation in the 2015 International Kinetic Art Exhibit and Symposium or use of the exhibitor’s space. Nothing contained in this release shall be deemed to affect the rights, privileges and sovereign immunities of the City of Boynton Beach as set forth in Section 768.28, Florida Statutes.
- 4.** I will always act professionally with customers, 2015 International Kinetic Art Exhibit and Symposium committee/management/staff and fellow vendors. Failure to do so may result in removal from the Symposium and may prohibit future participation at the City of Boynton Beach.
- 5.** I voluntarily assume all risk of loss, damage, or injury, including death or my property sustain in connection with this Symposium. By my signature, I release the City of Boynton Beach and its employees or agents from any liability for negligent acts or omissions for the duration of the event. I am fully aware of the risks and hazards of participating in this event and elect voluntarily to engage in such activity.
- 6.** I understand the exhibitor space fee shall not be refunded in the event that I do not attend or if all or part of the show is cancelled due to fire, calamity or any other act of nature, public enemy, strikes, statutes or ordinances or any legal authority or any cause beyond the control of the City of Boynton Beach.
- 7.** I agree that City of Boynton Beach may have unlimited use of any photographic medium that contains my likeness or image in any publication for publicity or commercial purposes.
- 8.** Additionally, I understand that the City of Boynton Beach makes reasonable attempts to attract qualified attendees to this event, but does not guarantee specific volumes or attendance levels.
